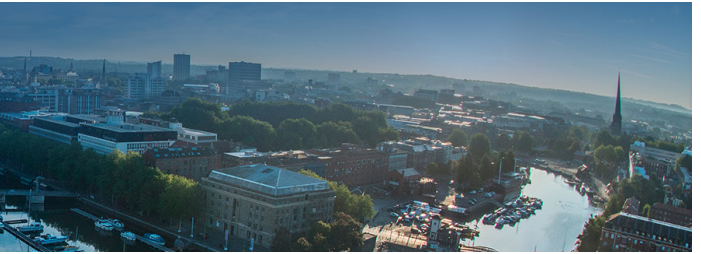

Introduction

This privacy policy sets out how Barcan+Kirby uses and protects any information that you give us when you use:

We're committed to ensuring that your privacy is protected. Should we ask you to provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

Barcan+Kirby's privacy policy sets out the ways the firm processes personal data. Any personal data collected by Barcan+Kirby (or its agents) is used in accordance with data protection legislation.

We may change this policy from time to time by updating this document and you should check this document to ensure you're happy with any changes. This policy is effective from 1st April 2015.

Controlling your personal information

Barcan+Kirby complies with the principles of the Data Protection Act 1998, and aims to maintain consistently high levels of best practice in its processing of personal data. Personal information provided to Barcan+Kirby will be used for the purposes outlined at the time of collection.

We do not sell your information, but processing personal data may entail sharing the information with employees, contractors, agents and professional advisors servicing Barcan+Kirby. For instance, we do occasionally enter into joint projects with other organisations so that we can offer a better service to you. At these times it may be necessary to allow third party agents access to personal information to provide these services.

This access is strictly limited to specific agents and for specific purposes and activities. We protect your privacy with written agreements between Barcan+Kirby and the other party that there must be no disclosure or further processing of such personal data.

You may choose to restrict the collection or use of your personal information in the following ways:

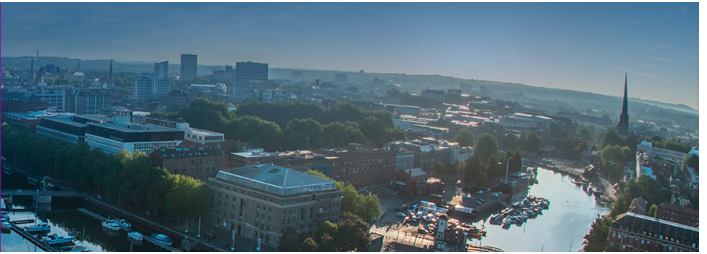

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

As you browse through our website, our web server collects information about your visit using traffic log cookies.

We gather and monitor statistics such as:

- + the number of people who visit the website
- + the number of pages viewed and the left of time spent on the site
- + the most popular sections of the website.

This information is anonymous and no attempt is, or will be, made to identify individual visitors.

Overall, cookies help us provide you with a better website by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any information about you, other than the data you choose to share with us.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. However, this may prevent you from taking full advantage of the website.
