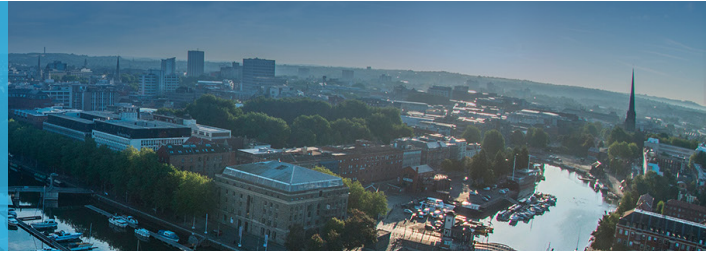


Corporate and Commercial Lawyer
